**Instructions to Return Your Completed Application**

1. Complete application.
2. Include a valid government-issued identification (ID) with **updated name AND** proof of Name Change. Copies must be legible and include clear picture AND information.
  - For example, acceptable ID: State-issued Driver's License/ID Card, or Passport.
  - For example, acceptable Name Change documentation: Updated Social Security Card, Marriage License, Divorce Decree, or Court-issued document.
3. Return application, a copy of your ID, and Name Change documentation via:
  - Online Banking:** Log into Online Banking to send a secure message. In the top right, next to profile, click the message icon. Click "compose" then "attach files" option in the message center to attach a copy of the form and photo ID.
  - Mobile Banking App:** Log into the Mobile App to send a secure message. In the bottom right, click "more." Click message center, click "compose" then "attach files" option in the message center to attach a copy of the form and photo ID.
