## Instructions to Return Your Completed Application

- 1. Complete Application. Please complete owner(s) information in entirety and add payable upon death beneficiaries (if applicable). Please make sure all owners sign Application.
- 2. Include Identification (ID)\*. Valid Government Issued Identification (for each owner). Copies must be legible and include clear picture AND information. Ex. State Issued Driver's license/ID card, Passport or Military Identification.
- 3. You May Return Form and ID copy by:

Online Banking: Log into Online Banking to send a secure message. In the top right, next to profile, click the message icon. Click "compose" then "attach files" option in the message center to attach a copy of the form and photo ID.

Mobile Banking App: Log into the Mobile App to send a secure message. In the bottom right, click "more." Click message center, click "compose" then "attach files" option in the message center to attach a copy of the form and photo ID.
